Results for 2007 A huge thank you to all who maintained their nest box lines through 2007 and took the time and trouble to submit a summary of their results. Your efforts and input are much appreciated, as well as vital to bluebird survival in our area. The numbers of fledges are down somewhat from 2006, undoubtedly due to the heat wave of mid-summer. Many monitors have reported losses of both bluebird and tree swallow young due to excessive heat. On a more positive note, a record number of boxes were monitored for nest success rates and fledgling numbers. In Memoriam: Charles Findlay (Shoal Lake)

passed away at the age of 95 this past summer. His lines were the forerunners of the ones that the Pettingers now monitor.

Notes from the Lines: Edith Parsons

(Minnedosa) reported an unusually fine season - no infertile eggs and all hatchlings fledged (47 new bluebirds)! Jack Bryer (Boissevain) noted a decline in EABL numbers on his line near Russell.

Larry Romaniuk (Winnipeg) is now the weather editor for the new Harrowsmith's Truly Canadian Almanac-check it out!

Doug & Genella MacIntyre (Brandon) as well as Ed & Yvette Huzyk (Carberry) reported increased mortality of birds, probably due to herbicide spraying. Brian Burrows & Diane Chatwin (Miami) were visited by large migrating flocks of EABL during late Sept-Oct. The mild weather at that time seemed to prolong their stay, and Brian's bird bath was a temptation the bluebirds just couldn't resist. Edic Evans reported that 2007 marked her 25th year as a nest line monitor. Con gratulations Edie! A testament to the fascination of this pursuit. I wonder if others might, on their 2008 summary form, give us an idea of the length of their commitment? We'd love to know, and will share the information (unless you wish otherwise).

Bert Perey (Brandon), Barbara Robinson (Brandon), Linda & Gareth Boys (Rapid City), Bob & Jean Horton (Brandon) as well as the Danards (Killarney) noted increased nestling deaths, amongst Tree swallows in particular, most probably due to the heat wave in mid-summer. Janet Gross (Mayfair Colony, Killarney) used an imaginative approach to solving a problem caused by raccoons. She moved some eggs out of EABL nests that had been raided and placed them in two Tree Swallow nests. All 6 eggs subsequently hatched, and one group of 3 bluebirds fledged! Does this ever occur naturally in the wild? Well, Barbara Robinson recorded a nest south of Shilo in

1989 with 5 Tree Swallow and1 Eastern Bluebird young - all nestlings appeared to have fledged. Ray & Barb Pettinger (Shoal Lake) once again banded nestlings, a total of 95 birds (65 MOBL and 30 EABL). Both the Pettingers, as well as Gerard Wade (Brandon), experienced the shock of vandals attacking their lines this past season. The Pettingers had 28 boxes stolen in May, and Gerard had 15 boxes extensively damaged by fireworks. In both cases active nests with eggs/young were destroyed. If ever you should suffer losses due to vandalism (and many of us have), please follow the course of action that Ray, Barb and Gerard did: They notified the RCMP of the event (if you have physical/photo evidence of the loss, be sure to take it to the police). Harassment or destruction of song birds and their nests is a FEDERAL offense (Migratory) Birds Convention Act), and the RCMP may have to be gently reminded of that. Next, both teams wrote letters to the local newspapers outlining the problem. This latter action lets the vandals know that their actions have been noticed and reported, and several benefits might arise from this. Fortunately, events on the scale seen this summer are rare. Publicizing them can often help reduce their frequency.

Thanks to all who shared their experiences and thought with us this year. Remember, we love to read about any experiences you care to share with other members.

Premature Fledging: A Cautionary Note:

Remember that there are times when it is dangerous (to the birds) to open the lids of nest boxes. On average, Eastern Bluebird nestlings take 17-19 days to fledge, and Mountain Bluebirds 17-21 days. The young should not be examined after 12 days post hatching for EABL, and 14 days for MOBL. However, these figures are not written in stone, and if in any doubt whatsoever, err on the side of caution and leave the nest alone until the young are fledged. Why? If the young are disturbed after a certain age, they may flee the nest in fear. However, they are NOT ready to live outside the protection of the nest, even with

the help of the parents. Returning them to the box, if you can catch them, may not help. Having "fledged" once, they tend to leave again before really ready and often meet a sad end. If you check boxes every 2-3 weeks, you can be fairly certain of knowing what stage the young are at. If you sample less frequently you may be faced with the dilemma of not knowing what might be in the box you wish to check. One solution, if used with care, can solve this problem. If you are using a top opening nest box only, plug the nest box opening with a rag, and very cautiously slide the lid open. just enough to peek inside. If the young birds are looking up at you or otherwise appear restless, it's time to carefully secure the lid, quietly remove the nest hole plug and beat a quiet retreat! This technique should at least allow you to confirm that eggs have hatched, and perhaps obtain a count of young. Front opening boxes pose a real problem in this regard, I wouldn't recommend opening them unless you are quite certain of the age of the nestlings beforehand.

These precautions usually don't apply to Tree Swallows, whose young are much more tolerant of disturbance.

There is now a link at this site devoted to "control" of House Wrens. Since wrens are a protected species (their nests, eggs and young may not be legally disturbed), and since their presence often spells disaster for bluebirds nesting nearby, the hints found at this site may be very important to any monitor faced with rising numbers of wren nestings on their line. There are even plans for wren "barriers" on nest boxes!

Also, do feel free to avail yourself of the many books and pamphlets in the Anne Smith Lending Library available at our annual Spring and Fall meetings.
